## WAIVER OF LIABILITY AND ASSUMPTION OF RISK

In consideration of Kanab City and the Kanab City Recreation Department (collectively, "League Organizer") allowing me to participate in the Kanab City Youth Soccer League ("Event"), I understand and agree to the following:

1. I represent that I am in good health and in proper physical condition to participate in the event, and I am not and will not be under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in the Event. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event.
2. I understand and acknowledge the physical and mental rigors associated with the Event and realize that participation in the Event may involve risks and dangers which include, without limitation, the potential for serious bodily injury, permanent disability, paralysis, and death; loss or damage to property; exposure to extreme conditions and circumstances; accidents; illness; contact or collision with other participants, spectators, vehicles or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect course conditions; water, road, and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the League Organizer; and other undefined harm or damage which may not be readily foreseeable, and other presently unknown risks and dangers. I understand that these risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in the Event, or the acts, inactions, or negligence of the Event Organizer, and I hereby expressly assume all such risks and responsibility for any damages, liabilities, losses or expenses which I may incur as a result of my participation in the Event.
3. For myself and on behalf of my spouse, children, parents, guardians, heirs, and any legal and personal representatives, executors, administrators, successors, assigns, and agents, I hereby agree to fully release the League Organizer, its officers, agents, representatives, employees, and contractors from any and all liabilities, claims, or causes of action arising from or connected to my participation in the Event.
4. I certify that I have read this Agreement carefully and understand its contents. I consent to this Agreement freely and voluntarily, without any inducement, and intend for my signature on the application for the Event to serve as confirmation of my complete and unconditional acceptance of its terms.
5. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and will not affect the validity and enforceability of any remaining provisions.
6. **Parent/Guardian Waiver for Minors (Under Age 18).** As a parent/guardian of a minor child participating in the Event I represent that I am acting in such capacity and agrees to hold harmless and indemnify the League Organizer from all liability, loss, claim, or damage whatsoever which may be imposed upon said parties as outlined above and because of any defect in or lack of such capacity to so act. I release the League Organizer on behalf of the minor. I have read this agreement and understand it fully. I understand the risks of the Event as outlined above and assume those risks on behalf of the minor.
