I hereby inform the citizens of Kane County that candidates for the following offices will be elected at the upcoming General Election to be held on **Tuesday, November 3, 2020.**

The Declaration of Candidacy filing period for qualified political party candidates begins on **Friday, March 13, 2020 – Thursday, March 19, 2020** from 8:00 a.m. to 5:00 p.m. at the Kane County Clerk’s Office, 76 North Main, Kanab, Utah.

The Declaration of Candidacy filing period for local board of education candidates begins on **Friday, March 13, 2020 – Thursday, March 19, 2020** from 8:00 a.m. to 5:00 p.m. at the Kane County Clerk’s Office, 76 North Main, Kanab, Utah.

The Declaration of Candidacy filing period for Justices and Judges of Court of records begins **Wednesday, July 1, 2020 – Wednesday, July 15, 2020** from 8:00 a.m. to 5:00 p.m. at the Kane County Clerk’s Office, 76 North Main, Kanab, Utah.

The Declaration of Intent to Gather Signatures period for qualified political party candidates begins **Thursday, January 2, 2020 – Thursday, March 19, 2020** ends at 5:00 p.m at the Kane County Clerk’s Office, 76 North Main, Kanab, Utah.

Qualified political party candidates must submit nomination petition signatures no later than **14** days before the day on which the qualified political party holds its convention to select candidates for the elective office.

1. **FEDERAL:**

U.S. PRESIDENT AND VICE PRESIDENT: These positions will be elected for a four (4) year term.

U.S. HOUSE OF REPRESENTATIVES: One U.S. Congressman for a two (2) year term in the following Congressional District:

SECOND DISTRICT: The Second Congressional District consists of Beaver, part of Davis, Garfield, Iron, part of Juab, Kane, Millard, Piute, part of Salt Lake, part of Sanpete, Sevier, Tooele, Washington, and Wayne Counties.

2. **STATE:**

STATE EXECUTIVE: The following position will be elected for a four (4) year term.

- ATTORNEY GENERAL
- GOVERNOR
- LIEUTENANT GOVERNOR
- STATE AUDITOR
- STATE TREASURER

STATE SENATE: One member for a four (4) year term.

District Twenty-four (24) is located in Beaver, Garfield, Juab, Kane, Millard, Piute, Sanpete, Sevier, Utah, and Wayne Counties.

3. **BOARD OF EDUCATION:**

LOCAL SCHOOL BOARD: One member for a four (4) year term, from each of the following Kane County School Districts.

KANE COUNTY SCHOOL DISTRICT ONE (1) consisting of Kane County Precincts K2:A, K2:B, and CW:B.

KANE COUNTY SCHOOL DISTRICT TWO (2) consisting of Kane County Precincts K3:A and K3:B.

KANE COUNTY SCHOOL DISTRICT THREE (3) consisting of Kane County Precincts K4.

4. **JUDICIAL:**

SUPREME COURT: There will be a retention election for one (1) Supreme Court Judge, provided that the incumbent(s) whose term is expiring files during the filing period.

COURT OF APPEALS: There will be a retention election for six (6) Court of Appeals Judges, provided that the incumbent(s) whose term is expiring files during the filing period.

SIXTH DISTRICT: One (1) Judge in the Sixth Judicial District, which consists of Garfield, Kane, Piute, Sanpete, Sevier, and Wayne Counties.

JUSTICE COURT: Any Justice Court judge whose term is expiring shall be subject to an unopposed retention election in the county or counties in which the court to which the judge is appointed is located.

5. **KANE COUNTY:**

One member, for a four (4) year term, from each of the following:

- RECORDER
- TREASURER
