The Declaration of Candidacy filing period for local board of education candidates begins on **Tuesday, January 2, 2024 - Monday, January 08, 2024** from 8:00 a.m. to 5:00 p.m. at the Kane County Clerk's Office, 76 North Main, Kanab, Utah.

The Declaration of Candidacy filing period for Justices and Judges of Court of records begins **Monday, July 1, 2024- Monday, July 15, 2024** from 8:00 a.m. to 5:00 p.m. at the Kane County Clerk's Office, 76 North Main, Kanab, Utah.

The Declaration of Intent to Gather Signatures period for qualified political party candidates begins **Tuesday, January 2, 2024 - Monday, January 08, 2024** ends at 5:00 p.m at the Kane County Clerk's Office, 76 North Main, Kanab, Utah.

Qualified political party candidates must submit nomination petition signatures no later than **14** days before the day on which the qualified political party holds its convention to select candidates for the elective office.

1. **FEDERAL:**

These positions will be elected for a four (4) year term.

U.S Senate.

One (1) Senator for a Six (6) year term.

U.S House of Representatives

One Representative for a two (2) year term .

Congressional District:

SECOND DISTRICT: The Second Congressional District consists of Beaver, Garfield, Iron, Kane, Millard, Piute, Sevier, Tooele, Washington, Wayne Counties as well as portions of Davis, Juab, and Salt Lake Counties.

STATE EXECUTIVE:

The following positions will be elected for a four (4) year term:

3. **STATE BOARD OF EDUCATION:**

One member for a four (4) year term from each of the following State School Districts

District Fifteen (15)

LOCAL SCHOOL BOARD:

One member for a four (4) year term, from each of the following Kane County School Districts.

KANE COUNTY SCHOOL DISTRICT ONE (1) consisting of Kane County Precincts BU, CW:B, KA2:A and KA2:B

KANE COUNTY SCHOOL DISTRICT TWO (2) consisting of Kane County Precincts KA3:A, KA3:B and KA3:C.

KANE COUNTY SCHOOL DISTRICT THREE (3) consisting of Kane County Precinct KA4

4. **JUDICIAL:**

SUPREME COURT: There will be a retention election for one (1) Supreme Court Judge, provided that the incumbent whose term is expiring files during the filing period.

COURT OF APPEALS: There will be a retention election for One (1) Court of Appeals Judges, provided that the incumbent whose term is expiring files during the filing period

DISTRICT COURT: There will be a retention election for thirty (30) District Court Judges in the following districts, Provided that the incumbent(s) whose term is expiring files during the filing period:
